Please note that the general town tax is charged throughout a town including villages, if any. The unincorporated tax rate is charges in town areas outside of villages and towns that have villages. Therefore, if you live in the unincorporated area of a town that has villages you must add the two rates together to compute your total tax rate. In Greenburgh the general town rate is charged only in the villages and the unincorporated rate is charge only outside the villages.
